re: Letter of Agreement for Advocacy Services

Dear Mr. Wallum,

This memorandum shall serve as the engagement letter between Mission Springs Water District (the "Client") and Burke Rix Hines & Associates (the "Firm") for advocacy services related to the appropriation of \$35 million in funding for the Mission Springs Water District Groundwater Quality Protection Project.

Drawn from the Mission Creek Sub-basin aquifer, the Client serves some of the best-tasting drinking water in the entire world. In 1996, the Client became aware of a serious threat from the wastewater discharged from septic tanks and it's effects on the regional groundwater resources. The Client took action, developed the Groundwater Quality Protection Project and completed Phase I in 2006. The Client now seeks to initiate Phase II of the project and requires \$35 million in funding to begin construction.

In 2007, the Water Resources Development Act authorized \$35 million in funding for the construction of Phase II of the Groundwater Quality Protection Project. The Client has formed an assessment district with local residents to cover the remaining \$28 million in costs for Phase II of the project, however, these matching funds will expire in 2014. The Client is eager to have the \$35 million in funding so that Phase II can begin.

Because of the many complexities of this project, the Client has asked the Firm to assist with specialized government relations and public relations services to ultimately acquire the appropriation of funds for the project. The Client has invested significant time and funding into the project and requires immediate action to ensure the protection of the regional groundwater resources.

The Firm shall utilize its impressive network as well as in depth experience on the inner workings of United States Senate to facilitate discussions with key decision makers regarding the inclusion of this project. The Firm shall advocate on behalf of the Client by working closely with U.S. Senator's Barbara Boxer and Dianne Feinstein. The Firm shall maintain ongoing surveillance and communication, and monitor the progress and position of the project through the committee mark-up, initial vote and final passage of the appropriation.

Burke Rix Hines & Associates will register per the laws of the State of California and all applicable Local and State jurisdictions with regard to representation, if any. The Client also agrees to comply with State of California regulations regarding representation to include completion of required reporting documents, if any.

The Client agrees to retain the Firm effective immediately. The term of this engagement shall be for one year, effective the date of signature on this document. Extensions of this engagement period will be at the sole discretion of the Client. As compensation for the performance of these duties, the Client agrees to compensate the firm in the amount of \$285 per hour for work performed by a Senior Partner and \$150 per hour for work done by an Associate. These rates remain in effect for the term of the contract. The client shall also reimburse the Firm for normal miscellaneous expenditures such as travel and related meals and lodging as approved by the Client on a case-by-case basis.

In addition to the hourly fees outlined in this agreement, the Client shall compensate the Firm with a success fee of twenty five thousand dollars (\$25,000) upon successful procurement of any funding for the Mission Springs Water District Groundwater Quality Protection Project.



Except as set forth herein, this Agreement constitutes the entire agreement between the parties. The agreement can only be amended in writing, signed by the parties hereto. If these terms are agreeable to you, please countersign below and retain one copy for your files and return the original to the Firm.

## **Bob Burke, Senior Partner**

Bob Burke has been strongly involved in public and government affairs, public and legislative law and governmental relations for over 30 years. Beginning as an attorney he was central to the California campaign of Bobby Kennedy for President. Following the tragic events of this campaign he lived in Geneva Switzerland, working for an international financial giant in the transnational real estate arena. He followed this position by establishing his own legal practice in Paris France.

He was called back to the United States to serve as a senior strategist and advisor to the former Senator Birch Bayh. Continuing with Federal service he was called to work in several positions with the administration of Jimmy Carter in Washington, D.C.. Working closely with the Executive office, he managed the Congressional relations at NOAA for the United States' domestic satellite and spectral scanners. While in Washington, D.C. he further expanded his public service experience by serving as the International General Counsel to the Consumer Product Safety Commission.

Returning to his hometown of Los Angeles, Burke announced the formation of his boutique law practice, specializing in the practice of land use, environmental and commercial law. Appointed to the Appeals Board of the Building and Safety Commission by former Mayor Tom Bradley, he served as President of that Commission. He directed his practice to regulatory affairs and Administrative Law. He was named by Senate leader pro tem, David Roberti to serve as president of the California State Advisory Board on Alcohol-Related Problems. He was a founder of the Harvard AIDS Institute and president of the UCLA School of Law Board of Directors. Burke was president of the Board of Alternative Living for the Aging, a senior congregate housing non-profit in the Fairfax area. He is currently serving on the Board of the Los Angeles branch of Volunteers of America and Chair of their Property Committee. He also held with distinction a position on the Executive Committee of the State Bar Section on Public Law. Burke is actively integrated in the downtown business community with participation in the Greater Los Angeles Chamber of Commerce and the Central City Association. He is founding member of Bob Burke & Company, a lobbying firm specializing in municipal and county matters.

Bob Burke studied at Stanford University and UCLA. He graduated with a law degree (J.D.) from the UCLA School of Law and studied for an LL.M at the London School of Economics. He is a member of the California Bar, the Washington D.C. bar and licensed to practice before the U.S. Court of Military Justice and the United States Supreme Court.
